In addition, United way pays donor designated funds for the Peninsula Combined Federal Campaign and the United Way Community Campaign directly to many 501c(3) organizations in the local area and nationwide.

UWVP helps children and youth achieve their potential through education. We invested \$704,920 in the academic success of approximately 38,000 children and youth residing on the Virginia Peninsula. Child Welfare - case management and education, adoption services and support to families in need.

UWVP helps families become financial stable and independent. Through a \$565,000 investment in providing help in times of crisis or disaster.
